Ancorra can provide all necessary paperwork to accompany your load in accordance with environmental legislation ensuring that your activities are fully compliant and auditable.

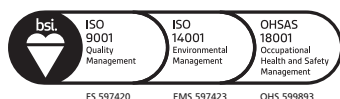
