In addition to traditional decommissioning solutions, such as cement slurry and tank removal, we are proud to be able to offer the alternative cost effective option of foam injection utilising our specialist equipment and Basel resin.

Unlike concrete there is no need to gas free the tanks before injecting the resin. All that is required is for the tanks to be emptied of residues beforehand, as the foam absorbs any hydrocarbons left present in the tank, rendering the tank inert and safe.

As the foam weighs only 25kg per 1000 litres it remains easy to remove the tank at a future date. Alternatively, depending on the original condition of the tank, the resin can be easily removed and the tank put back in to service.

Ancorra will prepare all necessary risk assessments and method statements and will liaise with the appropriate Licensing Authority on your behalf prior to undertaking any work.
